## CALL FOR PAPERS FOR SROTASWINI VOL IV (PEER REVIEWED JOURNAL)

In recent times, multiculturalism has been widely understood as being concerned with cultural diversity or, in other words, with "differences embedded in culture." Multiculturalism, consequently, has been fetishized by liberal democracies and parodied by those who view its implications shallow or untenable. Considerable heat and friction are generated in the struggles where the homogenizing, assimilative tendencies of the dominant groups are challenged by the dissenting claims of the others, not the least those who happen to be situated "in between." As cultures and communities navigate and negotiate relations in the globalized world, the space where both confrontations occur and compromises are worked out assumes significance.

Women are an integral part of this multicultural space. The claims of women, albeit more extensively articulated in this period than in the previous one hundred years, are yet to be fully documented, analyzed and realised. In many societies, women have been formally granted rights and opportunities equal to men. However, in the developing countries discrimination in terms of gender strongly exists. Sexual discrimination is seen as a fundamental tradition in a country like India. The practice of repressive cultures, whether it is directed against women or any other group viewed as being lesser, marginal, different, deviant, or dangerous, must always remain central to any debate on the subject of multiculturalism. Keeping in view the relevance of the subject cited above, a number of sub themes have also been framed to facilitate interdisciplinary treatment, observation and investigation on the subject from varied vantage points. The sub-themes are given below:

- 1. Women in Multicultural Spaces around the World: Exploration and Experiences.
- 2. Women and Social/Cultural Assimilation.
- 3. Women and Discrimination (Racial/Ethnic/Professional) in Multicultural Spaces.
- 4. Law and Justice for Women in Multicultural Spaces.

- 5. Women, Education, Employment and Entreprenuership in Multicultural Spaces.
- 6. Women and Cultural Norms: Prescription and Proscription.
- 7. Women, Superstition and Myth- Making in Multicultural Spaces.
- 8. Women, Nation and State.
- 9. Women and Conflict Resolution in Multicultural Spaces.
- 10. Women, Media and Communication in Multicultural spaces.
- 11. Women, Sports and entertainment in Multicultural Spaces.
- 12. Women and Leadership in Multicultural Spaces.
