5. The participating contractor shall have to possess their own technically qualified and experienced team for accurate implementation of the proposed work as per architectural and structural drawing to be provided by the undersigned from time to time.

### **Other Terms and Conditions:**

- 1. Project site may be inspected before collecting and submitting Tender documents.
- 2. Building materials will be supplied by the College authority during the execution of the work.
- 3. Rate should be quoted in flat percentage basis i.e., above/below/at per Scheduled rates for Building (Only labour Cost for civil works) for the year 2013-14 of all division under PWD, Assam
- 4. Rates must be quoted both in figure & words legibly and clearly.
- 5. The rate should be quoted considering all the taxes, duties and other levies as per Govt. rule and the same will deducted from the bill as per the prevailing rules.
- 6. The contractor must have their own machinery and equipment for **Pile foundation**, and other civil works to be used in the said work.
